

## **National Do Not Call Registry – Authorization Form Client Statement of Registration**

To comply with the new Federal regulations enacted by the FTC and FCC, Conclusive Analytics, Inc., its vendors, and other list service providers, must obtain certification and proof of registration from customers who wish to append or verify consumer lists with telephone numbers flagged or suppressed based on the National Do Not Call Registry.
